




#### **Cost position in 2003**



#### Norway - Cost development in NOK

- Feed
- Sea lice
- But all costs increase






#### Canada - Cost development in CAD




- Moderate cost increase
- Increased feed cost
- Good biological results
- Increased volume in 2015
- Favourable currency development
- Small sites, less efficient operations
- Difference between east and west
  - Natural conditions
  - Scale and technology
  - Growth potential



#### **Chile** Cost development in USD




- Rapid increase to 2009
- Moderate increase since
- ISA-crisis 2007-2009
- Disease challenge in later years (SRS)
- Increased smolt cost
- Cost effect of stricter regulations
- In-efficient site structure
- Volcanoes, predators, algae blooms



#### Scotland Cost development in GBP

- Steady cost increase
- Feed and health costs
- Expensive smolt
- Small sites, less efficient operations
- Regulation, certification, strong public interest






### **The Faroe Islands**


- Cost development in DKK

- Cost decrease till 2009, after ISA-crisis in 2003
- Steady growth since 2009
- Consentration and large-scale operations
- Strong health regulations
- Numbers are «best in class», both biologically and economically
- Lice is a challenge








#### **Economic Feed Conversion Ratio**


